

1. 收集 閣下個人資料的原因

2. 用途

- 處理 閣下的申請及退款支票(如適用)核 實是否符合本申請表格及招股章程載列的條 款和申請程序以及公佈公開發售股份的分配 結果;
- 遵守香港及其他地區的適用法律及法規;
- 以證券持有人(包括香港結算代理人(如適用))的名義登記新發行證券或轉讓或受讓證券;
- 存置或更新本公司證券持有人的名册;
- 核實證券持有人的身份;
